## Irish History #91

#### Lead Up to the 1916 Caster Rising

The nation of Ireland was shaped by important events that began in 1913 and continued through the end of the civil war in 1923. These years marked Ireland's revolutionary decade. We will review the civil war in upcoming chapters. For now, we will take a look at the impactful things that happened during the years leading up to the 1916 Easter Rising.

A revival of Irish cultural heritage took place in the late 19th century. The Gaelic Athletic Association (GAA) was formed in 1884 in Thurles, Co. Tipperary, to promote Irish football and hurling (see chapter 66) throughout the country. These were considered to be uniquely Irish sports, while soccer and rugby were viewed as foreign sports. In 1893, Douglas Hyde (a future President of Ireland) and Eoin MacNeill formed the Gaelic League to promote the Irish language (Gaeilege).

Arthur Griffith established the Sinn Fein (Ourselves Alone) political party in 1905, as an alternative to the Irish Parliamentary Party (IPP) which had spent decades trying unsuccessfully to achieve "Home Rule for Ireland." There was also an Irish literary renaissance during this period. W.B. Yeats and others started the Abbey Theatre in Dublin.

The revival of Irish "cultural nationalism" influenced revolutionary leaders. For example, Padraig Pearse taught at an Irish language school and Michael Collins played hurling. Revolutionary leaders were also influenced by the physical force philosophy of the Fenian movement and Irish Republican Brotherhood (IRB). Like the Fenians before them, IRB adherents believed the use of arms, not politics, was necessary to deliver Irish independence from British rule. A growth in IRB ranks accompanied this revival.

When Fenian and IRB man Thomas (Tom) J. Clarke returned to Ireland from America in 1907, he provided leadership to new IRB members. In 1911, the IRB formed a Supreme Council who would decide when the time was right for a rebellion. Clarke was appointed to the Council. Later, he was given the honor of being the first to sign the Proclamation of the Irish Republic. He was also part of the first group - along with Pearse and Thomas MacDonagh - to be executed after the Easter Rising failed.

The British government led by the Liberal Party finally enacted a Home Rule for Ireland Bill in 1912. It was the third attempt over a 26- year period to win passage, and it happened only after a new law came into effect that blocked the power of the Conservative dominated House of Lords to veto any law passed by the House of Commons. All the Lords could do after the legislation was delay any new

law's effect for two years. 1914 became the Home Rule Law's date of effect. The law triggered furious opposition in Ulster.

Once again, chants of "Ulster will fight" rang out in the north of Ireland. Frenzied threats of insurrection against a home rule parliament in Dublin were made. Sir Edward Carson led the charge. He organized "Ulster Day' on September 28, 1912. 470,000 men signed the "Solemn League and Covenant," pledging: "... throughout this time of threatened calamity to stand by one another defending for ourselves and our children our cherished position of equal citizenship in the United Kingdom and in using all means which may be found necessary to defeat the present conspiracy to set up a Home Rule Parliament in Ireland." Another quarter million women signed their own version of the covenant.

British Conservative party leader Andrew Bonar Law promised to "support" them in their treason. He urged "violent resistance" in a speech, saying: "We regard the government as a revolutionary committee which has seized upon despotic power by fraud. In our opposition to them we shall not be guided by the considerations or bound by the restraints which would influence us in a normal constitutional struggle. We shall take the means, whatever means seems to us most effective, to deprive them of the despotic power which they have usurped and compel them to appeal to the people they have deceived." This was a grossly irresponsible and reckless position for the leader of the opposition party in Parliament to espouse.

It became clear that violent protest was not a baseless threat the following year, when unionists established the Ulster Volunteer Force (UVF). This private paramilitary army, trained by retired soldiers, numbered over 100,000. Despite a government ban on arming, the UVF smuggled 35,000 German rifles and 5 million rounds of ammunition mainly through the port in Larne, Co. Armagh, in 1914. As 300 tons of material was unlawfully unloaded, "police and customs officials stood by idly" and watched.

This was not a surprise. Army and law enforcement officials had no intention of ensuring that home rule was implemented. A month earlier, a majority of British Army officers stationed at the main military base in Ireland, Camp Curragh in Co. Kildare, made clear they would not confront a population opposed to the law. The incident is known as the "Curragh Mutiny." British Commanding General Arthur Paget informed London via telegram that he and 57 officers preferred dismissal to obeying orders to move north. None

of the mutineers were court-martialed. Instead, London provided Paget a document that said "troops under our command will not be called upon to enforce the present Home Rule Bill on Ulster, and we can assure our Officers."

Law and order had clearly broken down. The outbreak of World War I (WWI) in August 1914 averted further confrontation. British Prime Minister Herbert H. Asquith agreed to postpone the Home Rule Law's effective date until the war's end. By then, however, home rule would "no longer be enough for the majority of Irish nationalists" on the island.

Unionist behavior throughout this period greatly affected nationalists. In response to the UVF, Eoin MacNeil set up the Irish Volunteers as a defensive force in 1913. IPP leader John Redmond controlled the Volunteers' movement in the beginning. But the IRB took a keen interest in the organization and infiltrated it. A dozen members of the Volunteers' executive committee were IRB members. The Volunteers split during WWI. A majority followed Redmond into the British Army to fight the war. About 11,000 Volunteers, however, remained in Ireland and trained for action against the British that culminated in the Easter Rising.

After the UVF's successful but illegal landing of arms at Larne, the Irish Volunteers staged a "mini-version" of their own gun-running. Erskine Childers, his wife Molly and Mary Spring Rice landed 900 German rifles aboard the yacht Asgard at Howth, Co. Dublin. As Pearse put it, "the only thing more ridiculous than a unionist with a weapon was a nationalist without one." 800 Irish Volunteers marched with the rifles to Dublin, 8 miles away. Along the route they were challenged by the British Army and Dublin police, but managed to get away with the weapons. As the soldiers returned to their barracks, a hostile crowd at Bachelors Walk threw stones at them. The soldiers responded by opening fire on the crowd, killing four and wounding 37. Nationalists saw the stark contrast between the deaths at Bachelors Walk and the lack of action at Larne as another example of "one law for Green and another for Orange."

The IRB Supreme Council met soon after the start of WWI, and decided to organize a rebellion in Ireland before the war's end. "England's difficulty" was viewed as "Ireland's opportunity," and the war offered these elements. The decision resulted in the 1916 Easter Rising.

As the war continued, this miasma of affairs simmered like a stew in a pot. The contents boiled over during a seminal event in 1915 - the funeral of Jeremiah O'Donovan Rossa. According to historian Dermot McEvoy, when O'Donovan Rossa died in Staten Island, Fenian John Devoy in New York wired Tom Clarke in Dublin asking "what should I do?" Clarke responded that O'Donovan Rossa's body should be

sent "home at once," meaning returned to Ireland.

O'Donovan Rossa grew up in Skibbereen, Co. Cork, one of the hardest hit areas during An Gorta Mor (the great hunger). "Dear Old Skibbereen" is an Irish folk song about the famine. The disconsolate song was sung in the movie Michael Collins, and many artists including the Dubliners, Wolfe Tones and Sinead O'Connor have recorded it. In one verse, a father explains to his son why he left Skibbereen: ". . . Oh it's well I do remember, that bleak December day. The landlord and the sheriff came, to drive us all away. They set my roof on fire, with their cursed English spleen. And that's another reason that I left old Skibbereen."

O'Donovan Rossa joined the IRB, and managed its newspaper - the Irish People. The British considered the newspaper's "uncompromisingly republican" opinions to be seditious. He was arrested along with Devoy and others, and charged with treason felony and attempting to levy war on the Queen. He was convicted of treason and sentenced to life in prison. The Amnesty Association, established to win the release of Fenian prisoners, got O'Donovan Rossa placed on the ballot for an open seat in the British House of Commons. Despite his imprisonment, he was elected an MP from Co. Tipperary. British Prime Minister William Gladstone granted amnesty to the Fenian political prisoners on the condition that they leave Ireland. O'Donovan Rossa and Devoy were among those released who journeyed to the US aboard a steamer-ship, the SS Cuba.

O'Donovan Rossa left Ireland but he did not leave the fight for Irish freedom. From the US, he organized and funded a Fenian dynamite campaign in Great Britain. Dynamite, the invention of Alfred Nobel, made it possible for one person to attack and kill many. It was a new and deadly way to instill terror. For O'Donovan Rossa, it leveled the playing field against a more powerful opponent. He was the mastermind of "the first ever Irish bombing campaign on British shores," and he recruited Clarke to be one of the bombers. Clarke was convicted for his role in London bombings, and sentenced to life imprisonment. He served 15 years before release, at which time he emigrated to the US and worked with Devoy.

Living in Ireland once again when O'Donovan Rossa died, Clarke wanted his body returned home so the IRB could make his funeral a spectacle. And that is what happened. O'Donovan Rossa laid in-state at Dublin City Hall. From there, MacDonagh and an advance guard of Irish Volunteers led his funeral procession to Glasnevin Cemetery. A contingent from the Irish Citizen Army and the Cumann na mBan followed the advance guard. It was estimated that 200,000 people lined the city streets along the miles-long route to the cemetery.

A funeral mass was said at the cemetery chapel. After

a blessing at the gravesite, Pearse, wearing his uniform, delivered a famous eulogy that suggested the torch for Irish freedom was being passed from an older generation to a younger one. It set forth justification for the upcoming Rising, and it noted the concept of "blood sacrifice" (i.e., the idea that success should not be measured in military terms, but measured in terms of how the "example of patriotism encourages future generations to rise up against British rule."). He pledged to Ireland his generation's "love" and "to English rule in Ireland our hate."

Pearse ended his speech with the following immortal words: "Our foes . . . cannot undo the miracles of God that ripen in the hearts of young men the seeds sown by young men of a former generation . . . Life springs from death; and from the graves of patriot men and women spring living nations. The defenders of the realm have worked well in the secret and the open. They think they have pacified Ireland. They think they have purchased and intimidated the other half. They think they have foreseen everything, think they have provided against everything; but the fools, the fools, the fools! They have left us our Fenian dead, and while Ireland holds these graves, Ireland unfree shall never be at peace." (During the Troubles, the underlined inspirational words were painted on the sides of buildings in West Belfast.) The ceremony concluded with a volley of shots fired over the grave by Volunteers.

Some view Pearse's speech to be the unofficial launch of the Rising that took place during Easter week 8 months later. On the Rising's first day, it was the oratorical Pearse who read the Proclamation of the Irish Republic on the steps of the General Post Office.

That Proclamation states in part: "TO THE PEOPLE OF IRELAND - Irishmen and Irishwomen: In the name of God and of the dead generations from which she receives her tradition of nationhood, Ireland, through us, summons her children to her flag and strikes for her freedom. . . We declare the right of the people of Ireland to the ownership of Ireland, and to the unfettered control of Irish destinies, to be sovereign and indefeasible. . . {W}e hereby proclaim the Irish Republic as a Sovereign, Independent State. . . In this supreme hour the Irish nation must, by its value and discipline, and by the readiness of its children to sacrifice themselves for the common good, prove itself worthy of the august destiny to which it is called." (emphasis added).


